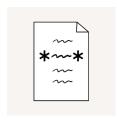
## **About Easy Read**

## Why did we do our webinar?



We did our webinar to talk about changes in \*reassessments\* by the NDIA.



Reassessments mean the NDIA checks if your supports need to change.



Reassessments might mean

your disability support stops



your disability support changes.



The NDIA is doing more reassessments than in the past.

#### Our survey findings



We made a survey to see how people felt about reassessments.



222 people did our survey including

parents and caregivers



 young people with disability aged 25 or under



NDIS participants.



The survey showed that some groups are reassessed more than others.



## Groups reassessed more than others include

• children aged 9 and under



Autistic children



• \*First Nations\* children



people from diverse backgrounds.



Many people who did the survey felt

scared



· confused.

#### **About the webinar**



The webinar was about your \*rights\* and the \*NDIS\*.



Rights are things that everyone should have.



For example, we have the right to be safe.



The NDIS supports disabled people.



The \*NDIA\* is the organisation that runs the NDIS.



Legal and disability experts spoke at the webinar.

#### First Nations people



We want support for \*First Nations\* people.



First Nations people are

Aboriginal



• Torres Strait Islander.



First Nations people have \*cultural rights\*.



Cultural rights include learning Aboriginal language.



We want the NDIS to support cultural rights.



#### We want the NDIS to

listen to First Nations people



work with First Nations organisations.

#### **Autistic children**



We want support for \*autistic\* children.



Autistic means you have autism.



Autism is about how you

• think



• feel.



Autistic people are born with autism.



Autism does not go away.



We want the NDIS to

• listen to autistic people



• work with autistic people.

#### Reassessments



We want help to understand reassessments.



We want the NDIS to give people more time to go through reassessments.

#### Help from an advocate



You can talk to an \*advocate\*.



An advocate is an expert who can

help you speak up



• speak up for you.



You can get help with reassessments from an advocate.

#### How to get a review



You can ask for a \*review\* if you are not happy with your NDIS plan.



A review is when a new NDIA worker reads information about you to check your plan.



The new worker can

agree with the reassessment



 not agree with the reassessment and change your plan.



You have 90 days to ask for a review.



To ask for a review you can

call the NDIA



• email the NDIA.

#### How to make an appeal



If you are not happy with the review decision, you can \*appeal\*.



An appeal is when an outside expert

reads information about you



says if you can get disability support.



If you need a reassessment, you can ask for

more information



• more time.



You can ask for help from your

family



• friends



• support workers.

#### We need more information



We do not know how the NDIS will change.



We do know

 there will be new support for children 0 to 8 years old



many children will not get NDIS support



• the NDIA will do more reassessments.



We need more information so we can understand changes to the NDIS.
